



BondCrete

A Poly-vinyl Acetate Bonding Agent for Cementitious Products



COVERAGE

Approximately 200ft² to 300ft² (18.6m² to 27.9m²) per gallon as a bonder.

Coverage may vary due to ambient temperature, surface temperature, surface porosity, and/or application methods.

PACKAGING

1 gallon (3.8L) bottles
5 gallon (18.9L) pails

STORAGE

1. Store pails in a cool, dry location.
2. Store at a temperature between 40°F (4°C) and 90°F (32°C).
3. Store out of direct sunlight.
4. Protect pails from weather and other damage.

PRODUCT DESCRIPTION

BondCrete is a superior liquid bonding agent composed of a polyvinyl acetate homopolymer resin specially designed to bond new cement-based and gypsum plaster products to existing properly prepared cement-based substrates.

BASIC USES

BondCrete is designed for exterior and interior use to bond new concrete, cement plaster, cementitious products, and gypsum plaster mixes to structurally sound concrete substrates.

AREA OF USE

As a bonding agent over:

1. One coat products
2. Brown coat
3. Stucco
4. Masonry
5. Poured-in-place and/or tilt-up concrete
6. Approved Omega base coats
7. Gypsum plaster
8. Acrylic or water-based paints
9. Mortar setting beds; fast set mortar
10. Grout

Application Instructions



BONDCRETE

SURFACE PREPARATION

All surfaces to receive the application must be clean and free of debris, dirt, dust, efflorescence, grease, oils, curing agents, and cleaning solutions. Ensure that all surfaces are smooth and free of any irregularities. Repair all cracks with the appropriate patching material for the existing substrate. Glossy surfaces must be roughened to ensure a proper bond.

MIXING

Mix the BondCrete thoroughly, immediately prior to use.

THIS PRODUCT IS NOT TO BE DILUTED.

APPLICATION

BondCrete may be applied with a brush, roller, or airless sprayer.

1. Ensure that the receiving surface has been properly prepared according to the Surface Preparation section of this Product Data Sheet.
2. Apply a coat of BondCrete onto the receiving surface when surface is dry or damp, but not wet.
3. Apply the desired finish when the BondCrete becomes tacky to the touch or up to 10 days later.

NOTE: Protect product from inclement weather.

DRYING

Drying time may be as little as one hour depending on surface and ambient temperatures and surface porosity. Protect the applied area from inclement weather until the application of new coating is installed. Do not allow product to freeze until fully dry.

LIMITATIONS

DO NOT use BondCrete when the ambient and/or surface temperatures are below 40°F (4°C).

DO NOT add any other materials to the mixture of the product without written approval from Omega Products International.

DO NOT deviate in the mixing or application procedures contained in this, or any other Omega Product Data Sheets, without written approval from Omega Products International.

DO NOT apply BondCrete if there are contaminants on the receiving surface. Contaminates may include, but are not limited to, dust, debris, efflorescence, and/or oils.

DO NOT use BondCrete as an admixture.

NOTE: Failure to follow manufacturer's written specifications could result in the following, but not limited to spalling, cracking, peeling, chipping, delamination, discoloration, wash off, and overall system failure.

CLEANING

Cleaning may be accomplished with water immediately after use.

SAFETY

Avoid contact with eyes or prolonged contact with skin. Wash thoroughly after handling. In case of eye contact, flush immediately with running water for at least 15 minutes. Consult a physician immediately. Do not take internally. Be sure to provide adequate ventilation in enclosed areas. Use of an approved respirator is recommended.
